TEAM UPDATES



Development Trusts Association Scotland

In the last year the COSS Team has supported 84 new cases of DTs and community groups considering taking on assets and a further 127 existing projects develop their proposals. Interestingly, there has been a strong interest in land with 57% of these new enquiries including a distinct land component.

Facilities management and building efficiency was of particular interest during the year with those at both the pre and post-acquisition stage of asset ownership keen to explore the best approaches available to make improvements. This will continue to be an area of focus for COSS during the coming year.

Interest in church assets has also increased significantly. In conjunction with the Heritage Trust Network and Historic Churches Scotland, COSS produced the Your Church, Your Community publication to assist communities consider implications of taking on church buildings. To support this, a further workshop programme is planned.

DTAS' Community Shares Scotland (CSS) programme has had a productive year, supporting numerous groups with democratic finance guidance. This has led to the launch of 7 community share offers, collectively raising over £750k. The CSS team also launched its first fully supported community bond offer, for a Space and Flight Visitor Centre in Kinross, which reached its ambitious target of £250k.Community led tourism has been a key trend this year with Northton Heritage Trust on Harris, Glengarry Community Woodlands and Alloa Hub demonstrating creative and sustainable approaches.

In addition, CSS delivered a series of CPD training sessions - these were offered to third and public sector community development advisors to upskill on community business and democratic finance.

The most exciting advance this year has been the development of a national Democratic Finance programme, in partnership with Scottish Communities Finance Ltd. The programme will be a significant remit expansion for the CSS team and will focus on supporting communities to use other models of local democratic finance that increase community wealth.

Community Ownership Fund (COF)

DTAS is now part of a UK-wide consortium providing support to communities looking to access the Community Ownership Fund. This fund allows communities to acquire and develop assets that are at risk of being lost through sale, dereliction or an unsustainable business model. We oversee the delivery of a wide range of support in Scotland, ranging from responding to initial enquiries and delivery of webinars to an indepth support package which helps communities develop a strong application. DTAS has already supported over 50 organisations and will work with many more over the next two years.

Pockets & Prospects (P&P)

The Pockets and Prospects programme continues to lead with a light touch, non-prescriptive approach for community-anchor organisations, taking a bottom up rather than top-down approach. DTAS believes that communities can better support grassroots projects, developments and build local partnerships when funding is given directly to them and produce better outcomes as a result. In 2022 to 2023, 30 groups received funding of £213.000.

Strengthening Communities Programme (SCP)

Continuing to work with Scottish Government in this transformational programme, our two dedicated SCP staff are currently working with a total of 31 community anchor organisations throughout Scotland.

We have also supported 12 members to access the SG capital funding, providing the support and assistance to shape their applications and ensure that they are in shovel ready positions. £473k of capital funding has now been invested in these members and enabling building refurbishment/adaptations/renovations, floodlights, accessible toilets and community gardens.

Working with the wider DTAS team, a further 5 organisations are being supported through this programme for 22-25 cohort. This has involved having team discussions on the membership and potential developments that organisations have coming up to ensure that they are at the right stage of development for the fund.

DTAS would like to acknowledge the ongoing financial support received from Scottish Government from their Third Sector Unit, the Social Justice and Regeneration Division and the Land Reform Unit. This year we gratefully acknowledge support from Acorns 2 Trees as well as ongoing grant funding from the National Lottery Community Fund for the Community Shares Scotland programme and the William Grant Foundation for our facilities management pilot programme.

This year, DTAS joined a UK-wide consortium working in partnership with the UK Government Department of Levelling Up Housing and Communities to provide assistance with the Community Ownership Fund.

Conference 2022

This was the first in-person conference since before Covid. 211 delegates attended the event including DTAS members, earlystage groups, associates, local authorities, government etc. The conference theme was 'Gather, Connect and Thrive' with a focus of bringing people together to share ideas, be inspired and voice their needs.

Regional Events

Throughout the year, we hosted 5 regional network meetings. These sessions provide an essential opportunity for members at all stages of developments to meet each other across Scotland. At the end of the year, 35 members had attended events all over Scotland in Skye, Tain, Isle of Kerrera, Isle of Gigha and West Lothian.

Webinars

A total of 119 people attended a range of webinars. The sessions continue to be popular and provide support and information on a wide range of topics with several partners including: HR & Health and Safety Essential; VAT; Community Shares; Inclusive Innovation; Local Transport Solutions; Paths Development LTS; Cycling Scotland; Home Energy Scotland; Crown Estate Scotland - Sustainable Communities Fund; Rural Housing and Just Enterprise.



Wellbeing: Supporting the workforce

Over the last 12 months, we've been prioritising staff wellbeing within DTAS.
