The National Lottery Community Fund Scotland and the Scotlish Land Fund



These sessions will be split between The National Lottery Community Fund and the Scottish Land Fund so you can choose to attend both on one day or come along to one each day.

The National Lottery Community Fund is proud to award money raised by National Lottery players to communities across Scotland. Our team will be in the Marketplace and will tell you about how our funding programmes are able to support community groups and local development trusts. In particular we have National Lottery Awards for All funding for community projects of up to £10,000, grants of up to £150,000 for community led activity and we'll talk about our new funding specifically aimed at environmental activity linked to COP 26, "Together for Our Planet".

Our Scottish Land Fund team and staff from Highlands & Islands Enterprise will give an overview of the <u>Scottish Land Fund</u> which we manage in partnership on behalf of The Scottish Government. The fund provides grants of up to £1 million to help local communities take ownership of land, buildings and assets to become more resilient.

Each session will consist of an overview of the funding, hints and advice on applying, and the opportunity to arrange a follow up 1-1 discussion on your idea if we're not able to do this during the session.
