Paths For All (Smarter Choices, Smarter Places)

Smarter Choices Smarter Places (SCSP) is Paths for All's grant programme funded by Transport Scotland. The ethos of SCSP is that effective behaviour change is achieved by empowering local projects to deliver local priorities, engaging local people to be the 'trusted voices' of change. SCSP is an outcomes-based programme, with five key outcomes. Funded projects encourage people to change their behaviour to reduce the number of single passenger car journeys undertaken across Scotland. Projects may achieve this by encouraging people to walk, wheel or cycle as part of their everyday short journeys, by supporting people to use other sustainable travel choices for longer journeys, or by assisting organisations to adopt home-working practices. It is available to public, third and community sector organisations.
